<p>A hazard is something that may cause harm or damage. The risk is the harm that may occur from the hazard.</p>	For example: young people, adult volunteers, visitors	<p>Controls are ways of making the activity safer by removing or reducing the risk. For example, you may use a different piece of equipment or you might change the way you do the activity.</p>	<p>Keep checking throughout the activity in case you need to change what you're doing or even stop the activity.</p> <p>This is a great place to add comments which will be used as part of the review.</p>
<p>For example: Hazard: fire Risk: smoke inhalation or burns</p>	Leaders, visitors, Young Leaders, Scouts	<p>Smoke: use dry wood, check wind direction, stand people out of smoke direction. Burns: stay a safe distance from fire, place extra wood on carefully, teach Scouts good practice around fires, have a burn first aid kit easily available.</p>	
<p>Pedestrian collision Serious major injury</p>	All	<p>5 mph speed limit signs. Area illuminated with floodlighting when dark. During busy times, staff in high visibility clothing to direct traffic and pedestrians.</p>	
<p>Vehicle collision Major injury and vehicle damage</p>	All	<p>5 mph speed limit. One way system in place. Car park illuminated when dark and bays marked out. Vehicle registration system in place for busy periods.</p>	
<p>Uneven surface Slips & trips for pedestrians Damage to vehicles</p>	All	<p>Inspect and fill potholes. Clearly mark holes for pedestrians to see.</p>	
<p>Branches and leaves Slips and trips for pedestrians. Damage to vehicles</p>	Crew	<p>Trees in car park to be inspected for damage and age/condition and if necessary, employ arborist. Clear entrance and paths to site to remove leaves and twigs.</p>	
<p>Covid considerations</p>	All	<p>The Quarries campsite has a separate Covid 19 Risk Assessment that is updated and reviewed in line with the Scout Association readiness level and</p>
